Based on the information you've shared and the little I know about you and your child's situation, the college entrance exam that's right for your child, is the ACT.

Here's What That Means...

Now here's what that means: What that means is your child will likely score highest on the ACT, which is the standardized test used by colleges for admissions and scholarships for financial aid.

The ACT is a 3-hour standardized exam that is out of 1600 points. The subjects covered on the ACT include Math, Reading, and Writing. Most students take the ACT during their 11th grade or 12th grade year before they apply to college.
